About Tariff of Empty Container Services at Tan Cang My Thuy & Tan Cang Tan Van Depot

Pursuant to Clause 2, Article 1, Decree 72/2024/ND-CP of the Government about the value added tax reduction policy according to Resolution No. 142/2024/QH15 dated June 29, 2024 of the National Assembly;

According to the proposal of the Business Planning Department, Finance and Accounting Department of Tan Cang Logistics & Stevedoring Joint Stock Company;

Based on the actual situation.

In order to be appropriate to Tariff of Sai Gon New Port at Cat Lai and to improve quality of empty container services at Depot Tan Cang My Thuy, Tan Cang Logistics would like to announce Tariff of Empty Container Services at Tan Cang My Thuy & Tan Cang Tan Van Depot (exclusive of VAT), effect from 01/08/2024, as follows:

A. CONTAINER HANDLING SERVICE CHARGE:

1. Handling charge at CY:

2. Other regulation for empty container:

- a. For empty container handled 01 time for simultaneous tasks such as repairs, PTI, rail installation....Handling charges shall be calculated based on the service bearing the highest charge.
 - b. For designated container:
- b.1. Requirement for monitoring of designated empty container shall be accepted only when the container shows "empty" status in container management system of SNP.
 - b.2. Terms of releasing designated containers::

If actual shifting volume is:

- + Less than 10 containers: Depot releases right after receipt of request
- + From 10-20 containers: Depot releases right after 24 hours of receipt of request
- + From 21-30 containers : Depot releases right after 48 hours of receipt of request
- + Over 30 containers: Depot shall agree with shipping lines/customers about the term of releasing empty container.
- b.3. Tariff of releasing designated container: as 150% in comparison to that of normal empty container.
