QUOTATION CFS WAREHOUSE

First of all, Tan Cang Warehousing Joint Stock Company sincerely thanks your company for its interest in our services. According to your request, we would like to provide the service quotation as follows:

1. General Regulations:

1.1 Weight Unit

The unit of weight used to calculate warehousing loading and unloading fees is RT (converted ton), with the following conversion rates:

- For light cargoes (i.e., cargoes with a volume-to-actual weight ratio (m³/ton) greater than or equal to 2), 1 RT = 2 m³ of actual cargoes recorded on the import/export warehouse documents.
- For heavy cargoes (i.e., cargoes with a volume-to-actual weight ratio (m³/ton) less than 2), 1 RT = 1 ton of actual cargoes recorded on the import/export warehouse documents.

1.2 Oversized/Overweight Cargoes (Group 1):

- Specifications: Cargoes weighing between 4 tons and under 7 tons, or cargoes with a volume between 8 m³ and under 14 m³, or cargoes with a length of 6 meters or more, and which the port's equipment can handle for loading/unloading.
- Unit price: 300% of the standard cargoes rate.

1.3 Oversized/Overweight Cargoes (Group 2):

- Specifications: Cargoes weighing 7 tons or more, or cargoes with a volume of 14 m³ or more, and which the port's equipment can handle for loading/unloading.
- Unit price: Negotiable, but not less than 400% of the standard cargoes rate.
- **1.4** For improperly packed cargoes, cargoes not meeting safety standards for loading/unloading, requiring the use of multiple equipment simultaneously for handling, or when port equipment cannot be used and external cranes must be hired, the loading/unloading fees will be negotiated with the customer depending on the specific case, but not less than 400% of the standard cargoes rate.
- **1.5** Minimum calculation 01 container 20' = 12RT and 1 container 40' = 18RT.

Minimum calculation 01RT will be applied for shipments with a chargeable weight of less than 1 RT.

- Dangerous cargoes and oversized/overweight cargoes are charged according to the port's general regulations.
- Ports within the Saigon Newport Corporation (SNP) system include: Tan Cang Cat Lai Port (TCCL), Tan Cang Hiep Phuoc Port (TCHP), Tan Cang Cai Mep International Terminal (TCIT), Tan Cang Cai Mep Thi Vai Port (TCTT), Tan Cang Cai Mep Port (TCCT), and Tan Cang Cai Cui Port (TCCC).
